Non-sanctioned Divisions:

Restricted Walk/Trot - Green Rider - rider has never competed above X-rails at a Combined Test.

Open Walk/Trot - Green Horse - horse may not be entered in any other division.

Both Walk/Trot Divisions Dressage: 2015 USDF Intro A

Indoor arena. Coats optional; half chaps allowed. Kimberwickes, Pelhams and standing martingales allowed. No twisted bits for dressage.

Both Walk/Trot Divisions Jumping: simple X-rail course 12 inches.

Indoor arena. Armbands are NOT required for jumping at this level.

<u>Baby Starter</u> - 2015 USDF Intro <u>B</u> Stadium: 2ft. max; no oxers. Dressage indoors; jump outside. Coats optional; no suede half-chaps; smooth snaffles only for dressage; armbands required for jumping.

MSEDA-sanctioned Divisions: **Coats optional for Stadium jumping thru Training per 2016 EV§114.7
