Mini Trial Fees: \$120 for Pre-Starter, \$140 for Starter and Beginner Novice. XC over rolling terrain, welcoming courses, no water, BN may have ditch and/or bank. No double entries.

Combined Test Fees: \$70, or \$120 for 2 consecutive levels (same horse rider combination), double entries allowed, second test/round hors concours. All tests ridden in small ring except Modified, Preliminary, and Intermediate.

Additional Jump Rounds: \$15 if already in same CT division, \$25 if a different division or not competing in CT.

Dressage Class Fee: \$30 per ride, double entries allowed, second ride hors concours. Classes 1-4 and 10 will be ridden in small ring, classes 5-9 in large ring. Classes may run out of order.

Refund: Refund in full less \$20 office fee prior to closing date. No refunds after close date, all changes must be in writing to organizer

Attire: Approved helmets and footwear must be worn at all times while riding. Braiding and coats not required. Riders must bring pinny holders for XC. *Medical armbands must be worn while jumping. Protective vest must be worn on cross-country.* **Ride Times**: Will be available on facebook page, email, and website by May 5.

Facilities: Limited stabling available at \$40/night. Shavings \$8/bag. Sand show rings, grass warm-up. Concessions available on site. Ribbons 1-6th.

Entries: Send entries to Lindsey DeAngelis, 128 Ashley Inn Way, Lancaster, KY 40444. Coggins and payment must be sent with entry. Entries must be postmarked by CD or incur \$25 late fee. *The organizer reserves the right to divide, combine, or cancel any divisions or classes.*
